- Ph.D. or Psy.D. in Clinical or Counseling Psychology from an APA accredited doctoral program
- License to practice psychology in the State of California or eligible within 6 months
- Thorough knowledge of diagnostic/psychological testing methodologies.
- · Ability to work in a highly collaborative manner with a diverse client group, members of the medical staff and faculty.
- Knowledge of electronic/medical records systems.
- Demonstrated experience working with African American communities.
- Demonstrated knowledge of Black Psychology and culture.
- Demonstrated ability to provide culturally appropriate therapeutic interventions.

Responsibilities

Psychologists are expected to provide individual therapy and assess the appropriateness of a short-term therapeutic modality for students with serious psychological concerns. Clinical service expectations include the ability to provide culturally appropriate interventions for the assessment and provision of crisis intervention services, coordination of care with Student Health and provision of appropriate referrals. Psychologists must be able to develop and deliver psycho-educational programs to meet the special needs of underserved populations, particularly the African American student population. Psychologists are expected to participate in campus organizations which have a demonstrated commitment to diversity and cultural issues and be able to approach clinical service provision from the perspective of Black Psychology and culture. Must be able to train and supervise staff, interns, practicum students, or peers as appropriate. Occasional evening and weekends will be required.
